**FIREWORKS SALES APPLICATION AND PERMIT**

(Pursuant to Sequim Ordinance Number 2012-005)

**1. PROCEDURES**

- A. Application shall be submitted at least 45 days prior to the requested effective date of the permit. No application shall be submitted prior to January 1 of the year in which such permit is requested. Complete below application.
- B. Attach copy of fireworks license issued by State Fire Marshal.
- C. Attach copy of insurance binder providing \$1,000,000 for bodily injury or death suffered by one or more persons in any one accident or occurrence; \$1,000,000.00 or more for property damage and products liability insurance of \$1,000,000.00 or more. (City must be named as an additional insured.)
- D. Attach performance bond, note, or cash deposit of \$110.00.
- E. Submit application and attachments with permit fee of \$100.00 to the Department of Community Development.
- F. The City's Fire Marshall shall review the application. Upon approval, it will be forwarded to Fire District #3 for comment.
- G. Upon the Fire District's approval, the permit will be signed by the City's Fire Marshal and Director of DCD and issued to the applicant. (Permit is non-transferable.)

**3. RULES AND REGULATIONS**

- A. No person, firm or corporation shall receive more than one permit for the sale of fireworks during any one calendar year.
- B. The City shall not issue more than one permit for each 1,500 persons residing within the Sequim City limits.
- C. Application for a permit within the City limits shall be made at least 45 days prior to the requested effective date of the permit. No permit application shall be submitted prior to January 1 of the year in which such permit is requested.
- D. All information submitted herein is true and correct.
- E. The sale, transportation, possession or discharge of unclassified fireworks within the City limits is prohibited. Fireworks must be marked with the manufacturer’s license number and the State Fire Marshal’s classification.
- F. The City Fire Marshall shall have the inherent authority to prohibit the use and sale of fireworks at any time when he or she deems such sale and use to be a danger to the public health, safety and welfare, and specifically when he or she deems the weather conditions to be such that there is an unacceptably increased risk of fire.

- G. Fireworks may be sold and purchased:
  - a. June 28 from Noon to 11:00 p.m.;
  - b. June 29 through July 4 from 9:00 a.m. to 11:00 p.m.; and
  - c. July 5 from 9:00 a.m. to 9:00 p.m.
- H. Temporary fireworks stands shall be in accordance with plans submitted to and approved by the Fire Marshal or Building Official. All temporary fireworks stands will be required to be constructed in a safe manner, assuring the safety of attendants and patrons. All wiring shall conform to the State and City Electrical Codes and be limited to the provision of adequate lighting.
- I. Applicant will abide by all requests of the City Fire Marshal or designee.
- J. Applicant agrees to indemnify and hold the City of Sequim harmless from any and all damages incurred either directly or indirectly, including reasonable attorney's fees, occasioned in whole or in part by an act or omission of applicant or applicant's agents.

I hereby request the City of Sequim issue a permit allowing the applicant to establish a temporary stand for the sale of fireworks within the City limits of the City of Sequim. The information submitted above is true and correct, and I have read the rules and regulations and agree to abide by those rules and regulations.

**TO: Fireworks Stand Operators**

**FROM: City of Sequim Fire Marshal**

**RE: Safety Requirements**

- Two (2) A fire extinguishers
- No smoking inside or within 25 feet of the stand
- No smoking signs conspicuously posted
- Grass, leaves or similar combustible materials within 25 feet of the stand must be removed
- If electricity is used, all aspects must meet Uniform Electrical Codes
- Notify the City Fire Marshal when fireworks arrive and where they will be stored until the stand is open
- Fireworks shall not be sold within this State except as indicated on the application
- Inspection of the stand will be made when it is set up on location. Spot inspections will be made during operating hours.
